AN ORDINANCE AMENDING THE CITY CODE

WHEREAS, The City of Momence, an Illinois Municipal Corporation, hereafter referred to as the "City", desires to allow compensation for the Treasurer regardless of attendance at counsel meeting; and

WHEREAS, The salary of the treasurer is and shall be remain set at \$4,800.00 annually; and

WHEREAS, In the past the treasurer was required to attend EVERY council meeting; and

WHEREAS, In the future the treasurer is only required to attend one meeting per month; and

WHEREAS, Chapter 11, Article 1, Section D of the Code of Ordinances of the City of Momence should be amended as follows: The Treasurer does not have to attend the first meeting of the month in order to be compensated.

NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND ALDERMEN OF THE CITY OF MOMENCE, KANKAKEE, COUNTY, ILLINOIS AS FOLLOWS:

SECTION ONE: The foregoing recitals shall be and are hereby incorporated into and made part of this Ordinance as though they were fully set forth in this Section 1.

SECTION TWO: Chapter 11 of the Code of Ordinances of the City of Momence shall be written as set forth above:

Sec 1D Compensation of Treasurer

SECTION THREE: Should any provision or section of this Ordinance be declared invalid by any Court of competent jurisdiction, such declaration shall not affect the validity of this Ordinance as a whole or any part hereof other than the part so declared to be invalid

SECTION FOUR: This Ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law.
