**ORDINANCE NO. 833**

**AN ORDINANCE AMENDING THE CITY CODE  
GENERAL PENALTIES**

WHEREAS, the City Council of the City of Momence, Illinois (“the City”) periodically reviews fines, penalties, and other regulatory matters as set forth in the City Code; and

WHEREAS, in accordance therewith, the City seeks to revise the penalties for violations of its City Code, having determined that to do so is in the best interests of the health, safety and welfare of the City and its residents;

WHEREAS, the City may exercise any power and perform any function pertaining to its government and affairs, including the power to regulate for the protection of the public health, safety, and welfare.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOMENCE, KANKAKEE COUNTY, ILLINOIS, as follows:

SECTION 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2: Momence City Code Title 1, Chapter 4, Section 1 “General Penalties,” is hereby amended thereto:
