**ORDINANCE NO.   831**

**AN ORDINANCE AMENDING THE CITY CODE**

**WHEREAS**, The City of Momence, an Illinois Municipal Corporation, hereafter referred to as the “City”, desires to allow compensation for the Treasurer regardless of attendance at counsel meeting; and

**WHEREAS**,The salary of the treasurer is and shall be remain set at \$4,800.00 annually; and

**WHEREAS**, In the past the treasurer was required to attend EVERY council meeting; and

**WHEREAS**, In the future the treasurer is only required to attend one meeting per month; and

**WHEREAS**, Chapter 11, Article 1, Section D of the Code of Ordinances of the City of Momence should be amended as follows: The Treasurer does not have to attend the first meeting of the month in order to be compensated.

**NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND ALDERMEN OF THE CITY OF MOMENCE, KANKAKEE, COUNTY, ILLINOIS AS FOLLOWS:**

**SECTION ONE:** The foregoing recitals shall be and are hereby incorporated into and made part of this Ordinance as though they were fully set forth in this Section 1.

**SECTION TWO:** Chapter 11 of the Code of Ordinances of the City of Momence shall be written as set forth above:

Sec 1D Compensation of Treasurer

**SECTION THREE:** Should any provision or section of this Ordinance be declared invalid by any Court of competent jurisdiction, such declaration shall not affect the validity of this Ordinance as a whole or any part hereof other than the part so declared to be invalid

**SECTION FOUR:** This Ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law.
