ANNUAL ABATEMENT ORDINANCE

ORDINANCE NO. 838_

ORDINANCE abating the tax hereto levied for the year 2017 to pay the principal of and interest on \$450,000 General Obligation Bonds (Alternate Revenue Source), Series 2010, of the City of Momence, Kankakee County, Illinois.

WHEREAS the City Council (the "*City Council*") of the City of Momence, Kankakee County, Illinois (the "*City*"), by Ordinance Number 696, adopted on the 18th day of October, 2010 (the "*Ordinance*"), did provide for the issue of \$450,000 General Obligation Bonds (Alternate Revenue Source), Series 2010 (the "*Bonds*"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS the Pledged Revenues (as defined in the Ordinance) have been determined by the City Council to provide an amount not less than 1.25 times debt service of all outstanding Bonds (as defined in the Ordinance) in the next succeeding bond year (December 1 of the current year and June 1 of the following calendar year); and

WHEREAS it is necessary and in the best interests of the City that the tax heretofore levied for the year 2017 to pay the principal of and interest on the Bonds be abated;

Now THEREFORE Be It Ordained by the City Council of the City of Momence, Kankakee County, Illinois, as follows:

Section 1. Abatement of Tax. The tax heretofore levied for the year 2017 in the Ordinance is hereby abated in its entirety.

Section 2. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the City Clerk shall file a certified copy hereof with The County of Kankakee, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2017 in accordance with the provisions hereof.

Section 3. Effective Date. This ordinance shall be in full force and effect forthwith upon its passage by the City Council and signing and approval by the Mayor.
