### **ORDINANCE NO. 853**

## AN ORDINANCE AMENDING CHAPTER 8 OF THE MOMENCE MUNICIPAL CODE MAKING CHANGES SO THAT THE CITY TREASURER SHALL BECOME AN APPOINTED OFFICE OF THE CITY OF MOMENCE

WHEREAS, 65 ILCS 5/3.1-20-5 permits a City with fewer than 10,000 inhabitants, by Ordinance, convert the position of City Treasurer from an elected position to an appointed position; and

WHEREAS, the Corporate Authorities of the City of Momence wish to make this change which will take effect at the conclusion of the term of the current City Treasurer.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOMENCE, KANKAKEE COUNTY, ILLINOIS, as follows:

<u>SECTION 1</u>: Chapter 8 City Treasurer of the Momence City Code shall be amended so that it shall hereafter read as follows:

1.8-1 Appointment. The City Treasurer shall be appointed and shall be selected from time to time in the same manner as other appointed officers of the City, which would be the salary of the appointed City Treasurer shall be that otherwise established by Ordinance or other official municipal action.

<u>SECTION 2</u>: Section 1-8-2 Bond shall be amended in that the beginning words of that Section shall be as follows:

Before entering upon the duties of an appointed Treasurer, such person so appointed shall furnish a good and sufficient bond to the City...

SECTION 3: This Ordinance amending a section of the Momence City Code shall be inserted as modifications to that document.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law but its terms shall only come into force at the time of the conclusion of the term of the existing elected City Treasurer and the appointment of an appointed Treasurer.
