ORDINANCE NO. 851

**AN ORDINANCE BANNING THE SALE OR
COMMERCIAL CULTIVATION OF CANNABIS WITHIN THE
CORPORATE BOUNDARIES OF THE CITY OF MOMENCE**

WHEREAS, the State of Illinois has permitted the commercial cultivation and sale of cannabis within the State; and

WHEREAS, the legislature has given each municipality in the State the ability to determine that no cannabis business may operate within the corporate boundaries of the municipality; and

WHEREAS, the City Council of the City of Momence has determined that Momence shall be a municipality in which neither the commercial cultivation or sale of cannabis products shall be permitted.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOMENCE, KANKAKEE COUNTY, ILLINOIS, as follows:

SECTION 1: Within the corporate boundaries of the City of Momence, there shall not be permitted any business establishment which shall cultivate or offer for sale within the corporate boundaries of the City any cannabis as that term is defined by the Cannabis Regulation and Tax Act, P.A., 101-0027, except in compliance with the Compassionate Use of Medical Cannabis Program.

SECTION 2: This Ordinance shall be a part of the Ordinances of the City of Momence although it shall not need to be made a part of the printed Momence Municipal Code. This Ordinance shall, however, supersede any provision of the Municipal Code with which it is in conflict.

SECTION 3: The adoption of this Ordinance being a matter of urgency due to the need to state the position of the City of Momence, it shall take effect immediately upon its passage and approval in the manner provided by law.
