#### MOMENCE CITY COUNCIL Monday, October 3, 2016 Council Meeting

The City Council Meeting of the City of Momence was held in the Council Chambers at 29 N. Dixie Highway, Momence. Mayor Mick Porter called the meeting to order.

#### ROLL CALL

Roll was called by the Clerk with Aldermen Denton, Navratil, Nova Metz, Steele, Rehmer, Cook, Lesyna and John Metz present. Also present was Mayor Mick Porter.

#### APPROVAL OF PREVIOUS MEETING MINUTES

Alderman Cook made a motion to approve the Regular and Executive Session minutes of the September 19, 2016, Council Meeting as presented. Alderman Nova Metz seconded the motion with Aldermen Denton, Navratil, Nova Metz, Steele, Rehmer, Cook, Lesyna and John Metz voting yes.

#### **APPROVAL OF THE BILLS**

## CITIZEN FORUM

Daniel Longtin addressed Council wondering what is being done about the south side flooding. City has been in contact with IDOT/engineers, idea is to run another storm sewer line on Locust or Walnut and tie into the state. Mr. Longtin wants City to split cost of check valve cannot plug, can be capped off, water has no way of getting out unless gets several inches high. Superintendent Behrends will investigate further.

## OLD BUSINESS

Alderman Navratil has investigated quiet zone regarding railroad whistles. Horns are to be blown 25 seconds before arrival at crossings and in order to make crossings a quiet zone, a diagnostic review has to be done. Cost estimate of \$185,000-\$500,000 to make the City a quiet zone, Union Pacific will do a quiet zone but liability wise, they do not like doing them. Consensus

was because of liability and financial cost Council does not believe it is worth pursuing.
