**AN ORDINANCE AMENDING THE CITY CODE**

**WHEREAS**, The City of Momence, an Illinois Municipal Corporation, hereafter referred to as the “City”, desires to remove the language regarding receiving notice from the building inspector, zoning board of appeals or city council.

**WHEREAS**, The City Code Enforcer shall be allowed to issue tickets directly to owners without the need for notice from the building inspector, zoning board of appeals or city council.

**WHEREAS**, Chapter 4, Article 2, Section 6 of the Building Regulations of the Code of Ordinances of The City of Momence should be amended as follows: Any person failing to number any building or other structure occupied by him after receiving written notice to do so from *City of Momence Code Enforcer* and who shall continue in his failure to so number such building or structure shall be fined fifty dollars (\$50.00) for each week during which a failure to so number continues.

Any person using a number for any building or structure other than the one assigned as provided in this chapter, after receiving notice from the *City of Momence Code Enforcer*, shall be fined fifty dollars (\$50.00) for each week during which a failure to conform to the correct number continues.

**NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND ALDERMEN OF THE CITY OF MOMENCE, KANKAKEE, COUNTY, ILLINOIS AS FOLLOWS:**

**SECTION ONE:** The foregoing recitals shall be and are hereby incorporated into and made part of this Ordinance as though they were fully set forth in this Section 1.

**SECTION TWO:** Chapter 2 of the Code of Ordinances of the City of Momence shall be written as set forth above:

**SECTION THREE:** Any person failing to number any building or other structure occupied by him after receiving written notice to do so from *City of Momence Code Enforcer* and who shall continue in his failure to so number such building or structure shall be fined fifty dollars (\$50.00) for each week during which a failure to so number continues.

**SECTION FOUR:** Any person using a number for any building or structure other than the one assigned as provided in this chapter, after receiving notice from the *City of Momence Code Enforcer*, shall be fined fifty dollars (\$50.00) for each week during which a failure to conform to the correct number continues.

**SECTION FIVE:** Should any provision or section of this Ordinance be declared invalid by any Court of competent jurisdiction, such declaration shall not affect the validity of this Ordinance as a whole or any part hereof other than the part so declared to be invalid

**SECTION SIX:** This Ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law.
