### TAX LEVY ORDINANCE

### City of Momence, ILLINOIS

ORDINANCE NO

WHEREAS, The City Council of the City of Momence, in the County of Kankakee, State of Illinois, did on this 17<sup>th</sup> day of July, 2017, pass the Annual Appropriation Ordinance for the said City for the Fiscal year beginning 1<sup>s</sup> day of May, A.D., 2017, the amount of which is ascertained to be the aggregate sum of \$6,999,350.00; which said Appropriation Ordinance was duly published to said City on 19<sup>th</sup> day of July, 2017;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MOMENCE, ILLINOIS:

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT YEAR COMMENCING ON THE 1<sup>ST</sup> DAY OF MAY, A.D., 2017 AND ENDING ON THE 30<sup>TH</sup> DAY OF APRIL, A.D., 2018.

SECTION 1: That there be and is hereby levied upon all taxable property within the corporate limits of the City of Momence, Illinois, subject to taxation for the year 2018, the total sum of \$457,740.65 for the following specific purposes mentioned in said Appropriation Ordinance in the respective sums as follows, to wit:
