

TAX LEVY ORDINANCE

City of Momence, ILLINOIS

ORDINANCE NO. 822

WHEREAS, The City Council of the City of Momence, in the County of Kankakee, State of Illinois, did on this 16th day of May, 2016, pass the Annual Appropriation Ordinance for the said City for the Fiscal year beginning 1st day of May, A.D., 2016, the amount of which is ascertained to be the aggregate sum of \$6,280,850.00; which said Appropriation Ordinance was duly published to said City on 18th day of May, 2016;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MOMENCE, ILLINOIS:

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT YEAR COMMENCING ON THE 1ST DAY OF MAY, A.D., 2016 AND ENDING ON THE 30TH DAY OF APRIL, A.D., 2017.

SECTION 1: That there be and is hereby levied upon all taxable property within the corporate limits of the City of Momence, Illinois, subject to taxation for the year 2016, the total sum of \$435,985.00 for the following specific purposes mentioned in said Appropriation Ordinance in the respective sums as follows, to wit:

SECTION III: This Levy Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code

SECTION IV: That there is hereby certified to the County Clerk of Kankakee County, Illinois, the several sums above, constituting said total amount and the total amount of \$435,985.00

Which total amount the City of Momence requires to be raised by taxation for the current fiscal year of the City, and the City Clerk of the City is hereby ordered and directed to file with the County Clerk of the County on or before the time required by law, a certified copy of this ordinance.

SECTION V: This Ordinance shall take effect and be in full force and effect immediately on and after its passage and approval.
