

ORDINANCE NO. 827

AN ORDINANCE AMENDING THE TERMS OF THE MEMBERS OF THE ZONING BOARD OF APPEALS

WHEREAS, the City Council of the City of Momence, Illinois is charged with the continued administration and oversight of the City Code Book; and

WHEREAS, the City Council of the City of Momence, Illinois has established that finding citizens to serve on the zoning board of appeals is an issue; and

WHEREAS, the City Council of the City of Momence, Illinois, has determined that the code book should be updated to reflect that actuality; and

WHEREAS, the City Council of the City of Momence, Illinois, has concluded that term limits for the zoning board of appeals should be eliminated; and

WHEREAS, the City Council of the City of Momence, Illinois wishes to amend the City Code, specifically under a portion of the Code known as Title 2, Chapter 5, Section 1, titled "BOARD ESTABLISHED".

NOW, THEREFORE, be it ordained by the City Council of the City of Momence, Illinois, as follows:

SECTION 1: That Title 2, Chapter 5, Section 1, titled "BOARD ESTABLISHED", of the City Code of the City of Momence, Illinois, is hereby repealed.

SECTION 2: That there is hereby added to the City Code of the City of Momence, Illinois, in Title 2, Chapter 5, Section 1, to be titled "BOARD ESTABLISHED".

TITLE 2

CHAPTER 5

2-5-1: BOARD ESTABLISHED:

There is hereby established a zoning board of appeals. Said board shall consist of seven (7) members appointed by the Mayor and confirmed by the City Council. Vacancies shall be filled by the Mayor, subject to confirmation by the City Council. Members may be removed by the Mayor for cause after written charges have been filed and after a public hearing has been held if demanded by the member so charged.

One of the members of said board shall be designated by the Mayor, with consent of the City Council, as chairman of said board, and shall hold office as chairman until a successor is appointed. Such chairman, or in his absence, the acting chairman, may administer oaths and compel the attendance of witnesses.

One of the members of the board, shall act as clerk for the board, and keep records of all its meetings and official acts.

SECTION 3: The provisions and sections of this ordinance shall be deemed separable and the invalidity of any portion of this ordinance shall not affect the validity of the remainder.

SECTION 4: That this ordinance shall be in full force and effect after its passage, adoption, and publication in pamphlet form, as required by law.
