The City Council Meeting of the City of Momence was held in the Council Chambers at 29 North Dixie Highway, Momence. Mayor Mick Porter called the meeting to order.

# **ROLL CALL**

Roll was called by the Clerk with Aldermen Denton, Navratil, Nova Metz, Steele, Kupferer, Cook and Lesyna present. Also present was Mayor Mick Porter. Alderman John Metz was absent.

# APPROVAL OF PREVIOUS MEETING MINUTES

Alderman Cook made a motion to approve the Regular Session minutes of the April 4, 2016, Council Meeting as presented. Alderman Nova Metz seconded the motion with Aldermen Denton, Navratil, Nova Metz, Steele, Kupferer and Cook voting yes. Alderman Lesyna passed.

Alderman Kupferer made a motion to approve promotion of Officer Caliendo to the rank of Sergeant, with contractual pay of \$46,969 with \$400 a month stipend (included in price), effective May 1, 2016. # MAYORAL REPORT

Discuss authorization to endorse the Kankakee River Kayak Trail. Council would be supporting a paddling trail from Southbend, Indiana to the end of Kankakee River. Letter of endorsement and support needed. Alderman Denton made a motion to approve Council's endorsement of the Kankakee River Kayak Trail. Alderman Kupferer seconded the motion. Motion carried with 7 Ayes 0 Nays.
