1.5 million in anticipated expenses, with the 25% increase total increase would = 314000.00.

City will not qualify for any grants/loans currently without showing an increase. Are we increasing enough? Should we look at 35% this year vs 25%? Rates have to be built into the ordinance prior to passing. Consensus needs to happen with the rate for each water and sewer, possible 40% increase to have 200,000.00 savings at year end. Question//answer time with industrial/commercial users and Baxter/Woodman possibly in July. Baxter and Woodman to draft letter for industrial, commercial and residential users.

Alderman Temple – Kristen Strunk resigned her duties from the police department on May 3, requesting executive session to discuss personal.
