## Treasurer report –

**MAYORAL REPORT** – Baxter Woodman, voting on next agenda, going over funding and expenses. The bill for sewer plant design, they get a percentage – total cost \$25,000,000.00). Baxter Woodman's fee is \$1,134,000.00. Project cost went up \$362,000.00. He will be requesting them to come to the next meeting to answer any questions. Rate study was done a couple of years ago by the EPA, and also another was done by Baxter Woodman. The city cannot get an IDPA loan at this time, not showing enough income, to finance our projects. Baxter Woodman will be doing another rate study, \$49,700.00, this is necessary to know where the city stands with the water/sewer rates. Mayor insists that with the potential increases, we are still lower that Aqua.
