Alderman Anderson as about FirstNet being an option. Mayor indicated that no one is using other than Bradley.

Department Heads – Chief Siemson – no issues with Netflix with the fire/snow/water main break. Netflix will be back on March 5, 6, 7 Lauri is doing well at the academy Nancy – NIBRS – good shape Corporal position – in discussion with the union City cleaners – will belong to the city Officer Blaskey – active duty in Africa Community clean-up – wants to do another day. The city is allowed 2 dumpsters/2 times per year Possible recovery for 327 Market Street – working with the bank

Scott – there was a water main break at 114 and Gladiolus – Popcorn place. This was hired out. The prop generator at the sewer is still leaking – getting pricing. This runs 2 blowers. If the loan goes through, the blowers will not be used.
