## MOMENCE CITY COUNCIL Monday, February 20, 2023 Council Meeting

The City Council Meeting of the City of Momence was held in the Council Chambers at 29 North Dixie Highway, Momence.

### ROLL CALL

Roll was called by the Clerk with Aldermen Doody, Carbonaro, Clark, Starkey and Lesyna present. Alderman Huddelston, Cook and Temple were absent.

### APPROVAL OF PREVIOUS MEETING MINUTES

### APPROVAL OF THE BILLS
