- We issued several citations for garbage cans being left out.
- The owner of the bowling alley related that he is in the process of getting it cleaned up

- I will be initiating a fee for sex offender registration effective 01/01/25 in the amount of \$100 annually.
- I am asking the council to consider the following, effective 01/01/26, anyone that has delinquent bills with the City of Momence will prohibited from receiving a golf cart registration until all bills are paid in full.
- A letter was sent to Stonecrest Manor requesting that they clean up the exterior area.
- I spoke with Ian Hellinsg's attorney Mr. Parrish who advised that he continues to attempt to resolve the issues with his property/renter on Indiana.
- Sgt Arroyo attended the Northwestern University two-week supervisor course.
- Sgt Arroyo will attend Northwestern University Staff and Command Course sometime in 2026. I am seeking reimbursement for both of these supervisory courses from our risk management group, IMPG.
- We have begun the long and arduous task of cleaning out the evidence room. So far, I have located 26 firearms that were not recorded or inventoried prior to my employment. We have approximately 75 additional firearms that were recorded/inventoried. All firearms will be reviewed, and we will seek destruction orders from the state's attorney office for those that can legally be destroyed. Once complete, we will start with other items of evidence that need to be destroyed.
- All new employees continue to perform well and without issue.
- The white Dodge was purchased from Route 1 and is being outfitted. The black Dodge and Ford Explorer will be outfitted next.
- The title for the Charger was signed over to the Squad shop.
- The Arson investigation continues.
- We initiated several narcotics investigations and have begun working with the FBI on one complex one.
- We are assisting with another sexual investigation with the state police.
- MPD will host a costume contest during the Bordertown Hauntings on 10/25.
- No legal updates
